### Introduction

Adopting a publication scheme is a requirement of the Freedom of Information Act 2000. The Act promotes greater openness and accountability across the public sector by requiring all 'public authorities' to make information available pro-actively, through a publication scheme. This publication scheme is in line with the Information Commissioner's revised Model Publication Scheme for Universities.
