Registration Agreement and Conditions

A. I declare that I intend to register with the University for the academic year of 2009/10, the information given on this form is true to the best of my knowledge and:

- 1. I agree to abide by the University's regulations and policies.
- 2. I have read and understood and agree to be bound by the terms of the <u>Intellectual Property Policy</u> of the University.
- 3. I accept responsibility for ensuring that my personal details are correct.
- 4. I accept that the University will take whatever steps it considers necessary to establish the authenticity of my personal information; fraudulent registrations will be cancelled and the appropriate authorities notified.
- 5. I have not been required to withdraw from this award, and I do not know of any reason why I should not be registered on it.
- 6. I understand that the University and/or its agents may wish to ascertain whether there is any similarity between work that I produce or have produced and that produced by third parties. I therefore hereby grant the University an irrevocable licence to use as it sees fit any and all results and material and outputs relating to my work/studies at the University (including but not limited to intellectual property; eg design rights and copyright etc) with the right to sub licence and to the fullest extent necessary in order for the University or its agents to ascertain whether there is any such similarity for the purpose of determining whether any plagiarism by myself or the third party has occurred.
- 7. I agree to abide by the <u>Chest Copyright Agreement</u> as included in the University's policies.

B. With regard to my tuition and other fees, I acknowledge that:

- 1. I am personally liable for payment of my fees unless I provide the University with acceptable evidence that a Local Authority/Student Finance, or other sponsor, has agreed to pay part or all of my fees.
- 2. Where my sponsor agrees to pay part of my fees I am liable for payment of the remainder and if my sponsor fails to pay I become immediately liable for that payment.

Should I withdraw from the University, any reduction in fee will be made in accordance with the reduction in fees and refunds policy explained in detail in the <u>Academic Registry</u> section of the University's website, section "Reduction of Fees and Refunds" which includes the condition that if I withdraw after the first 21 days of my programme the full fee (less administration costs) will be refunded only if the University has been able to replace me with another student.

C. Criminal Record Bureau (CRB) checks (students in Education and Health and Social Care only)

- 6. Under the terms of the Home Office Circular 6/2006 I agree to inform the police that I am a student (teacher) if arrested for any offence.
