### 4.2 Programme requirements:

The BA (Hons) Accounting and Finance (BAAF) programme seeks to provide a foundation for lifelong learning with a strong emphasis on the development of appropriate knowledge, skills and professional values essential to the exercise of an accounting and finance specialism, whether in industry or public practice. It has been designed to provide a thorough grounding in financial reporting, management accounting and corporate finance. It aims to develop technically competent, broad based individuals who think and communicate effectively and who have the basis for conducting inquiry, carrying out problem solving and undertaking critical analysis in a constantly changing business context.

BAAF can be studied either as full time or as a sandwich course. All sandwich students will undertake a work placement of a minimum of 40 weeks. This provides a rich process in which students can reassess themselves and confront the challenges of carrying out a role in a new organisation, whilst knowing that they will have the opportunity to be supported if there is a problem and that they will be returning to the programme for a further period of reflection and learning after the placement is completed.

The programme currently receives exemptions from ICAEW, ACCA and CIMA examinations.

BAAF graduates will be able to understand and apply the techniques and analytical tools used in the production of financial information for planning, decision making and control within organisations. They will understand the regulatory frameworks which govern financial reporting, and they will understand and be able to apply different ethical frameworks to evaluate financial decisions. In addition, graduates will have a clear understanding of the inter relationships between financial markets and the broader business environment. They will understand the principles, development and application of strategic business decision making. They will be competent users of IT in a business context and understand the purpose and operation of accounting information systems.

BAAF graduates will also develop employability skills such as the ability to work co-operatively in groups. They will be numerate and able to apply quantitative methods and statistics to business problems. They will have strong information literacy skills, being able to locate, evaluate and use data and information from multiple sources. They will be confident communicators, able to present, discuss and defend ideas, concepts and views effectively, both verbally and in written forms. They will be independent learners able to assess their own performance and seek and use feedback effectively, but will also have developed and demonstrated strong team working skills.

On completion of the programme, graduates will have developed technical accounting skills, but will also have developed as critical thinkers, able to examine problems and issues from a number of perspectives. They will be able to challenge viewpoints, ideas and concepts, and make well-reasoned judgments. They will be well prepared for their careers in accounting and finance roles.

### 4.4 Grading scheme details:

Honours Degrees are normally classified based on a weighted average and are awarded as follows:

70% or more First Class

60% to less than 70% Second Class, Division 1

50% to less than 60% Second Class, Division 2

40% to less than 50% Third Class

Unclassified Honours Degrees can also be awarded (Pass only) in order to meet professional body requirements.

Integrated Masters Awards are awarded a Merit at an average mark of 60% across a specified number of credits.

All other Awards of the university are awarded a distinction at an average mark of 70% across a specified number of credits. Foundation degrees are awarded a Merit at an average mark of 55% to less than 70% across a specified number of credits.


