We are looking forward to welcoming you in the week commencing 22 September for Starting Block and the beginning of your programme.

Once you have satisfied all admissions requirements, we'll send you your login details for our IT systems to enable you to activate your university email account. Note that your login details for MYUWE are different to those used for the UWE Welcome website. Registration for September programmes will only be open from August onwards. <sup>\*</sup>NOTE: the Real Estate Finance and Investment module is conducted through a one week's mandatory attendance <u>in person</u> in Bristol in the second semester of the programme (2026). The dates will be notified via your programme site in due course (provisionally week commencing 23 March 2026).

#### What to expect when classes start

Your programme is organised into subject areas called modules, and each module is assigned a credit value that contributes towards your final degree. Your Programme Leader will explain all modules to you at the start of the year. (On-line) attendance at timetabled sessions is expected.

In addition to the modules contact time and other timetabled activities, you are expected to organise approximately 12-15 hours of independent study time, every week, to complete assignments, read, research and revise.

Lectures will be recorded and made available on a weekly basis throughout the programme.

Students are also invited to join the <u>Commonwealth Association of Surveying and Land Economy</u> (CASLE). There is a £25 fee. The organisation works across the Commonwealth and would be a good means of establishing links with other professionals.
