

# Get ready for LLM Solicitors Training Course (SQE Prep)

## Introduction

Welcome to the Solicitors Training Course! We are here to help you prepare for the Solicitors Qualifying Examinations (SQE), the passing of which is an essential step in qualifying as a solicitor.

From 1 September, you will be registered on Blackboard which will be our means of communication with you as a cohort and will provide you with access to the teaching materials and additional resources.

The course will begin with an Induction Day on 1 September, when you will be required to attend campus for introductory lectures, to meet the teaching team and to collect your books. You will begin with four weeks of online self-study, with access to tutors during that period to answer your queries. During this period, you will need to attend campus on Monday mornings for further introductory lectures. Face to face teaching will begin in the last week of September. The teaching sessions will be on campus every Monday and Tuesday.

We are a team of dedicated current and former practitioners who will support you throughout the course. We are very much looking forward to meeting you all.

## Before you start

### Teaching

We are looking forward to welcoming you in the week commencing 1 September for the beginning of your programme.

Starting Block will help you settle into university and to help you get to know your teaching team and course mates. We will help you find your way around, get used to our systems, and practice the skills you need to make a strong start. ## **Registration**

Once you have satisfied all admissions requirements, we'll send you your login details for our IT systems to enable you to activate your university email account. Once your account has been activated, you'll gain access to the [MYUWE](#) platform where you can register. Note that your login details for MYUWE are different to those used for the UWE Welcome website. Registration for September programmes will only be open from August onwards. ## **ID card - upload your photo now**

## **Engage with your programme**

### **Read around your subject**

A key skill which is required to achieve a high level of success within your chosen programme is the ability to think critically about key issues and practices. To help you to enhance these skills and be ready to engage with your studies, you should start to read and research around your subject before you arrive. Explore the [Library](#) web pages to see the wide range of resources available to you once you become a UWE Bristol student.

### **Solicitors Training Course ("STC") suggested reading list**

This is a suggested reading list in advance of starting the course. It is **not** a requirement to read everything on the list but it is designed to introduce you to the SQE syllabus and topic areas we will be covering on the course. You may wish to use the guidance to brush up on your existing legal knowledge or explore new topic areas.

For SQE 1 we are covering a range of subjects which cover "black letter law" studied by those undertaking an LLB or the GDL, plus practice-based subjects which are covered on the LPC.

The black letter law subjects are:

- Public Law (constitutional & admin law, Legal Systems)
- Contract
- Tort
- Land Law
- Trusts
- Criminal Law

These 6 topics will be the focus of your online learning throughout September. You will receive guidance and access to materials to structure your learning, which will be followed up with teaching sessions from the last week of September to consolidate your learning and to practice some MCQs. The focus will then shift to the practice-based topics (see below).

You will be provided with some textbooks on the course. This will include 12 titles from the University of Law SQE prep books (Business Law & Practice, Dispute Resolution, Contract, Tort, Constitutional & Admin, Land, Legal Services, Property Practice, Wills & Admin of Estates, Land, Trusts & Criminal Law). In addition, you will receive the full range of OUP SQE e-books.

To get you going with the basic legal concepts, you may wish to do some reading in advance. Here is a list of the books we recommend to our GDL students:

Two other books which are worth a look are:

**Warning 1!** Don't try to read all these books cover to cover but use them to come to grips with the basic concepts in line with the SQE syllabus (see below).

**Warning 2!** Law books are expensive and become out of date very quickly. Ideally, seek to borrow books from a law library or friends/legal contacts. If you wish to buy, see if you can find the most recent edition on Ebay (for example).

The practice-focused subjects we are covering are:

- Criminal Practice
- Dispute Resolution
- Property Law & Practice
- Business Law & Practice
- Wills & Administration of Estates
- Legal Services & Solicitors Accounts

We will be focusing on these areas (which are the "LPC type" topics) in the teaching sessions from the end of September onwards. It is therefore recommended that you focus any pre-reading on the black letter law subjects above as this will set you up for the practice focused subjects which is more about application of your basic legal knowledge.

In order to focus some of your reading, take a look at the SQE 1 Syllabus:

You might find looking at this a little overwhelming at this stage, but it will give you an idea of the topic areas we will need to cover.

More information will be provided before the start of the course, but the above is designed to give you a global overview and perhaps a starting point for those who wish to get ahead over the summer.
